Calendar description: Classic and contemporary research pertaining to adult romantic relationships. Topics include attachment styles, relationship development, communication, and conflict in relationships.

Learning outcomes: Upon successful completion of this course students will be able to:

1. Understand the core theories and methods of research on interpersonal relationships
2. Be able to observe and apply the core theories and concepts to everyday life
3. Discuss and critique conceptual issues from theoretical and applied perspectives
4. Demonstrate advanced skills in scientific communication, both written and oral

Suggested Time Commitment: In this course, you should expect to invest on average 8 to 10 hours per week. This will include the time you spend in class, studying course material, and completing homework or preparing for your assignments and exams. You are encouraged to use a term at a glance and a weekly study schedule (visit [SASS](#)) that distributes the 8-10 hours per week and avoid 'cramming'. This way you will be more likely to complete the course successfully and remember what you learned longer.

Relationship column activities (30%)

1. Relationship column questions (2 at 5% each): Students will write two questions question directed towards a relationship column, based on course content. The submission should demonstrate an understanding of how course content can be observed and/or applied in everyday life. Submissions should be no longer than 250 words, including a brief bullet point description of the concepts from class that are related to the question. Students may select from any theme/topic covered in weeks 1-6 for question 1, and weeks 7-12 in question 2.
2. Relationship column responses (2 at 10% each): Students will be assigned 2 questions during the term and will write a response to an anonymous relationship column question (see above) based on the theories and concepts covered in the course. The submission should demonstrate an understanding of how course content can be applied in everyday life. Submissions should be no longer than 500 words, excluding references. Assigned questions TBA.

Seminar Presentation activities (45%)

1. **Seminar presentations (20%):** Each student will give 1 seminar presentation (schedule TBA). Students will be assigned a topic in the course and be tasked with selecting one empirical paper from the primary literature on the topic that is not covered in the lecture/assigned readings. Students will give a 20-minute seminar presentation on their selected paper to the class during Friday seminar sessions. Students are encouraged to consult with their professor on their selected paper. Papers must be submitted 10 days prior to the presentation date for posting to the class. Any presentation materials, such as slides, are due 3 days prior to the presentation in onQ. There are no substitutions or alternate assignments for the seminar presentation. If a student is unable to present on their assigned week for an approved reason, they will be rescheduled to present on either April 1st or 7th, at the discretion of the instructor.
2. **Seminar paper questions (2 at 5% each):** For each seminar presentation, a few students will be assigned to develop 1-2 discussion questions based on the focal paper. Questions should demonstrate conceptual understanding and critical thinking, e.g. by targeting alternative explanations of findings, limitations, methodological or conceptual issues. Questions should be no longer than 200 words in total, including a brief description of the rationale of the questions, and are due via onQ 3 days before the scheduled presentation. Schedule TBA.
3. **Seminar Reflection (2 at 7.5% each):** For each student seminar presentation, a few students will be assigned to write a brief summary of one of the seminar presentations/discussions. The summary should focus on the relevant theories and concepts, how they were applied/discussed, and what was learned from the session. Summaries should be no longer than 500 words. Schedule TBA. Seminar summaries are due 1 week after the assigned date.

Critique Paper (25%): For the critique paper, students will select a focal empirical paper from the primary literature, published in the last 5 years, that is not covered in lecture/assigned readings. Students should briefly summarize the paper, and present a rational, informed, and evidence-based critique of the study. Students must identify the following: the research problem/goal, the hypothesis, independent and dependent variables and their operationalization, and main findings. The critique must demonstrate knowledge of the relevant principles and issues covered in course content. The critique must also include a specific section on an original single future direction (not a reporting of future directions from the paper itself): what new question does this study raise, and what is a specific approach to investigating it? Additional details will be available onQ and discussed in class.

onQ : Throughout the term, I will routinely post course news in the Announcements section of the course homepage. I encourage you to actively check the course onQ main page for course announcements throughout the semester for reminders and additional course information or learning opportunities. If you have general questions about anything in the course and that your question may benefit other students, you are invited to post your question in the Course Questions discussion forum. Feel free to help answer your peers' questions on this forum.

Assessment of Learning Outcomes: Your grade in this course will be calculated based on your performance on the assessments as documented in this syllabus. There are no other opportunities for credit other than those documented in this syllabus. Grades on assessments are allocated based upon demonstrated mastery of the materials and skills as evaluated by the instructor. Students must complete the seminar presentation, critique paper, 1 of 2 relationship column responses and 2 of 3 seminar summaries in order to pass the course.

Grading Method: All components of this course will receive numerical percentage marks. The final grade you receive for the course will be derived by converting your numerical course average to a letter grade according to Queen's Official Grade Conversion Scale:

Assignment submission & Late assignments: All assignments are submitted through the course onQ. Emailed assignments are not accepted and will not be graded. Unreadable/corrupt/empty/incomplete or "incorrect" files or files that are not in the required format will be considered late and penalized accordingly until the assignment is properly submitted. Students are not permitted to revise their submissions in any manner once the deadline is passed. It is the student's responsibility to ensure that their document is (1) readable and (2) in the correct format.

In the interest of Universal Design for Learning, students are allotted a 72-hour grace-period for submission of all assignments (with the exception of the seminar presentation). Submissions after these deadlines will be subject to a 15% penalty per day and will not be eligible for credit 3 days after the grace period has expired.

1. **Plagiarism:** Presenting another's ideas or phrasings as one's own without proper acknowledgement. For example: Copying and pasting from the internet, a printed source, or other resource without proper acknowledgement, copying from another student, using direct quotations or large sections of paraphrased material in an assignment without appropriate acknowledgement, or submitting the same piece of work in more than one course without the permission of the instructor(s).
2. **Use of unauthorized materials,** such as possessing or using unauthorized study materials or aids during a test copying from another's test paper, using unauthorized calculator or other aids during a test, unauthorized removal of materials from the library, or deliberate concealment of library materials.
3. **Facilitation:** Enabling another's breach of academic integrity, such as by making information available to another student, knowingly allowing one's essay or assignment to be copied by someone else, buying or selling of term papers or assignments and submitting them as one's own for the purpose of plagiarism.
4. **Falsification:** Misrepresentation of oneself, one's work, or one's relation to the University, such as by altering transcripts or other official documents relating to student records, impersonating someone in an examination or test, submitting a take-home examination written, in whole or in part, by someone else, or fabricating or falsifying laboratory or research data.

Instead, it gives instructors the information they need to select the authenticity of work as a part of a larger process.
