The School of Religion at Queen's University invites applications from suitably qualified graduate students at Queen's University interested in teaching a course in **The Contemporary Religious Situation (RELS 452) as a Teaching Fellow**. This is an on-campus lecture course with an expected enrolment of ~25 undergraduate students. This is a Fall term appointment for the period September 1 to December 31, 2022 with classes in session from September 6, 2022 to December 5, 2022.

The University invites applications from all qualified individuals. All qualified candidates are encouraged to apply; however, Canadians and permanent residents will be given priority.
