**Proposal to introduce a new Bachelor of Fine Art Honours Major ARTF in the  
Faculty of Arts and Science**

**Introduction**

The proposal to introduce a new Bachelor of Fine Art Honours Major ARTF in the Faculty of Arts and Science was reviewed by the Senate Committee on Academic Development (SCAD) at its meeting of May 5, 2010. J. Pierce, Associate Dean of the Faculty of Arts and Science, attended the SCAD meeting to speak to the proposal and to answer questions from members of SCAD. Members of SCAD were also provided with background documentation provided by the Faculty of Arts and Science. A copy of the documentation is attached to this report.

**Analysis and Discussion**

The following should be noted:

- If approved, the Bachelor of Fine Art Honours Major ARTF will replace the current Bachelor of Fine Art Special Field Concentration;
- Introduction of a Major concentration that requires 10 core courses compared to 15 core courses for a Special Field Concentration will give students more flexibility when choosing electives. It will also provide a more sustainable teaching load for the Department of Art;
- Admission requirements will not change and qualified students will continue to be admitted directly into the Fine Art program. The number of students admitted into the Fine Art program will also remain the same;
- Students who wish to take Art History in conjunction with Fine Art can continue to do so by combining the BFAH Major ARTF with a Minor in Art History;
- Students who are currently registered in the Special Field Concentration will be given the option of remaining in the program or transferring to the Major program.

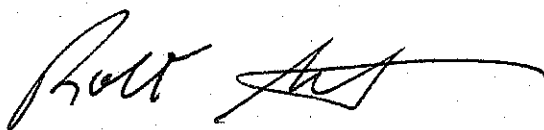

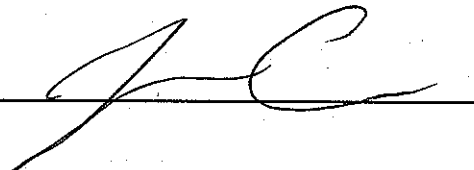

The BFAH Major ARTF is being introduced to replace the current BFAH SPF ARTF. The proposed BFAH Major ARTF requires fewer concentration courses (10.0 as opposed to 15.0 for the SPF) and will allow students the option of combining the Major with a Minor in other subjects. To construct the Major, the Fine Art curriculum committee has reduced the number of Art History courses originally required as part of the Special Field Concentration (SPF). The Fine Art concentration courses remain the same as in the SPF. Students who wish to have the full range of Art History courses as part of their degree will still be able to take the same combination of Fine Art and Art History courses by combining the BFAH Major ARTF with the Minor in Art History.

The BFA Major will bring the Fine Art program more in line with other Faculty of Arts and Science programs. It will also broaden student flexibility in course options. Students will benefit from the proposed BFA Major in that Fine Art course requirements will remain similar to the Special Field Concentration in terms of Fine Art course choices and credit requirements, similar to other Canadian University Fine Art program requirements. The requirement of two Art History courses will permit students' good flexibility in their other course selection and allow use of the two Art History Supporting credits toward a Minor in Art History.

It is hoped that this program can be offered beginning September 2010. Students who are currently registered in the SPF will have the opportunity to remain in the program until graduation; however, we will also allow those interested in transferring to the Major to do so during the course selection period in Spring 2010.

### 2. **ADMISSION REQUIREMENTS:**

The admission requirements (preparation and achievement) should be appropriate for the learning objectives of the program and the institution to ensure the appropriate quality of student applicants. In no case should admission requirements be lower than the published minimum standards for the University. Indicators of student demand including applications, registrations, projected enrolment levels, and of the quality of students must be considered. Where admission is competitive, actual admission requirements may be higher than the published minimum standards. Information about anticipated enrolments should also be included.

There is no change to admission requirements. Students will still apply directly to the Fine Art program and admission will be based on a combination of pre-university grades and on a portfolio submission.

### 3. **CURRICULUM:**

The proposed BFAH Major ARTF degree will require 20.0 credits: 10.0 credits in Fine Arts, 2.0 supporting credits in Art History and 8.0 elective credits. The first year Art History course requirement is ARTH 120; the second year Art History courses are recommended: ARTH 227 or ARTH 231\* and ARTH 232\*). The courses will be allotted as follows:

**1. CORE COURSES (10.0 credits)**

- a. 2.0 credits in ARTF 127/1.0, ARTF 128/1.0.
- b. 2.0 credits in ARTF 227/1.0, ARTF 228/1.0.
- c. 3.0 credits in ARTF 337/1.5, ARTF 338/1.5.
- d. 3.0 credits in ARTF 447/1.5, ARTF 448/1.5.

The Calendar Description will be as follows:

**Bachelor of Fine Art (Honours) - BFAH**

**Major Concentration - MAJ** (consists of 10.0 credits studio, 2.0 supporting credits and 8.0 elective credits to total 20.0)

**Fine Art - ARTF**

The program combines a balance of studio practice; theoretical, experimental and critical studies required in the practice of fine art, art history and other studies. It is suitable for students wishing to enter professions requiring visual arts training including art education at all levels. The demanding fine art content challenges students to develop their understanding of art through experience as artists as well as through historical studies. The practice of art is supplemented by a program of lectures and critiques from visiting artists and educators. Over the four years of study, students complete 10.0 credits in fine art, 2.0 supporting credits in art history and 8.0 elective credits. The 2.0 supporting credits in art history can be used toward a minor concentration in art history. A minor concentration, 5.0 credits in another field, is also possible.

To obtain satisfactory standing in any year, a student must achieve at least 60 per cent in all fine art courses required for the concentration and an overall average of 60 per cent. Normally, a student falling below 60 per cent in any fine art course will be required to repeat the course or to withdraw from the program.

The normal sequence of courses for the Major Concentration in Fine Art is shown below.

YEAR 1 ARTF 127, ARTF 128, ARTH 120; 2.0 elective credits.

*12 hours studio classes plus a minimum of 12 hours independent studio activities per week.*

YEAR 2 ARTF 227, ARTF 228, 1.0 credit in art history (ARTH 227 or ARTH 231\* and ARTH 232\* are recommended); 2.0 elective credits.

*12 hours studio classes plus a minimum of 12 hours independent studio activities per week.*

YEAR 3 ARTF 337; ARTF 338; 2.0 elective credits.

*24 hours studio activities per week.*

YEAR 4 ARTF 447, ARTF 448; 2.0 elective credits.

*24 hours studio activities per week.*

### **Transfer Students**

Applicants who have not completed a degree and wish to transfer to the Bachelor of Fine Art program from another accredited post-secondary institution must have completed the equivalent of ARTF 127 and ARTF 128 with minimum admissions average and undergo a portfolio examination. Applicants wishing to transfer to the Bachelor of Fine Art program from another Faculty or School at Queen's must have successfully completed ARTF 105 and ARTF 110 and undergo a portfolio examination. If admitted to first year, students must complete ARTF 127 and ARTF 128, and will lose credit for ARTF 105 and ARTF 110. If admitted to the second year of the program ARTF 105 and ARTF 110 will count for ARTF 127 and ARTF 128. Transfer into second year is extremely rare. All entrants into the Bachelor of Fine Art program with advanced standing must satisfy the academic requirements of the full program.

Studio spaces in Ontario Hall will be used for Fine Art course instruction. In addition, the BFA woodshop and department Multi-Media Lab will be used to support course teaching and also be used by students outside of class-time. As such, there is no change to in the physical resources required.
