## Course Description:

## MPA 814/3.0: Intergovernmental Policy

Attention focuses on patterns of interaction among governments, and between governments and organized interests in Canada, and in other federal or quasi-federal systems. A major subject is how such patterns of interaction are affected by the structure of political institutions, the allocation of powers, and fiscal considerations.
